## **CALL FOR NOMINATIONS**

Toronto Arts Foundation (TAF) invites you submit nominations for its 2010 awards. These awards celebrate artists, cultural professionals and arts supporters from every creative discipline. This awards program is designed to highlight the significant contributions made by our city's cultural leadership. Awards will be presented at the **Mayor's Arts Awards Lunch** in October. All recipients will receive an original work of art by a Toronto artist – each year TAF commissions a new work.

Deadline for nominations is Wednesday, June 30, 2010 at 5pm.

# **Award Descriptions**

**Arts for Youth Award** – a \$15,000 cash prize established in 2007 by Martha Burns, Jim Fleck and Jim Pitblado, this award celebrates an individual, collective or organization that has demonstrated an outstanding commitment to engaging Toronto youth in the arts.

**Toronto Arts and Business Award** – celebrates a local business which has made an important contribution to the arts in Toronto through innovative, transformative and entrepreneurial partnerships. .Established in 2006, this award is presented in partnership with The Globe and Mail, Business for the Arts and the Toronto Arts Foundation. In addition to a work of art, the recipient of this award will be recognized for their achievement in the Report on Business section of The Globe and Mail.

RBC Emerging Artist Award – a \$7,500 cash prize presented to an emerging Toronto artist working in the new media or performing arts discipline in celebration of current accomplishments and future potential. In addition, finalists will receive \$1,000 each. Established in 2006 by RBC Foundation, this award is intended to support the development or completion of new work.

Roy Thomson Hall Award of Recognition – a \$10,000 cash prize presented to an individual, ensemble or organization to recognize creative, performing, administrative, volunteer or philanthropic contributions to Toronto's musical life. This award was established by the Volunteer Committee of Roy Thomson Hall in 1984 to recognize and thank the community that supported the conception, building and establishment of the new concert hall. In 2002, the Corporation of Massey Hall and Roy Thomson Hall asked the TAF to manage the award.

William Kilbourn Award for the Celebration of Toronto's Cultural Life – a \$5,000 cash prize presented to an individual performer, teacher, administrator or creator in any arts discipline, including architecture and design, whose work is a celebration of life through the arts in Toronto. Established in 1996, this award is funded through an endowment made possible by private donors who wished to celebrate and remember the life of William Kilbourn who died in 1995. Kilbourn was a writer and teacher who spent seven years as a member of Toronto City Council, and served as Toronto Arts Council president from 1982 to 1984.

## **Basic Eligibility Requirements**

### Individuals:

- must be Canadian citizens or permanent residents of Canada, who have demonstrated an ongoing association with Toronto and who have contributed significantly to the arts and culture of Toronto
- must be living at time of selection
- may not nominate him/herself for the award and may only receive the award once (this does not preclude a recipient from being considered for a different TAF award in the future)
- are not eligible to receive TAF awards while serving as board or committee members of the TAF or Toronto Arts Council.

## Organizations and Collectives:

- must be headquartered in Toronto and have a significant portion of its activity taking place in the city and have contributed significantly to the arts and culture of Toronto.
- are only eligible to receive an award once (this does not preclude a recipient from being considered for a different TAF award in the future)

### Toronto Arts and Business Award:

- Open to businesses of any size operating in Toronto
- Businesses or business foundation supported by corporate funds may be nominated.
- May only receive this award once
- Must be nominated by a representative of a Toronto based arts organization

No person or organization may be selected for more than one TAF award within any given year.

## **Selection Process**

A jury of up to 12 members will review candidate profiles and make a recipient recommendation for each award to TAF Board of Directors, which will make final determinations. Jury members must have recognized expertise, prestige, credibility and experience along with a sense of history and perspective. Each jury is comprised of participants who are practitioners of the arts, organizers, programmers, producers, curators, critics, commentators and lay specialists. TAF will endeavour to ensure that the majority of jury members are arts and culture professionals. Nominations through this process are received from the public.

- CV: In order for the nomination to be considered complete, you must also attach a curriculum vitae or résumé of the nominee.
- Biography: All nominations must include a nominee biography up to 100 words in length. This biography will be used in press releases, on the website and in the program.
- Artist's Statement: All RBC Emerging Artist Award nominations must include a brief statement outlining how the award would serve to further the career of the nominee.
- Support Material: Where possible, it is recommended that you illustrate the nomination by including support documents. This can be in the form of print material (such as press clipping) or audio/visual items (VHS tape, CD ROM, DVD, URL, etc). If you are uncertain about the compatibility of your electronic materials, please contact the Foundation. Support material will be available for pick-up at TAF beginning Friday, October 30, 2010. Support material not collected by Friday, November 26, 2010 will be discarded.

### **POLICIES AND PROCEDURES**

#### Introduction

Toronto Arts Foundation Awards are designed to heighten public awareness of arts and artists in Toronto by recognizing artistic excellence and achievement.

Toronto Arts Foundation (TAF) presents its awards annually at a gala ceremony hosted by the Mayor of Toronto. Each award honours prominent practitioners, supporters and organizers whose work has made a major contribution to the artistic and cultural life of Toronto.

These awards are presented in recognition of a body of creative accomplishment, rather than for specific works or achievements.

### **Award Descriptions**

Although presented annually, the awards program may vary, as many honours are presented on a biennial schedule. With the exception of the *The Globe and Mail Toronto Business for the Arts Award* presented in partnership with Business for the Arts, each award is accompanied by a cash prize.

#### Awards for presentation in 2010:

**Arts for Youth Award** – a \$15,000 cash prize established in 2007 by Martha Burns, Jim Fleck and Jim Pitblado, this award celebrates an individual, collective or organization that has demonstrated an outstanding commitment to engaging Toronto youth in the arts.

**Toronto Arts and Business Award** – recognizes a local business that has made a significant contribution to the arts in Toronto. Established in 2006, this award is presented in partnership with Business for the Arts. The recipient will receive an original work of art created by Nobuo Kubota.

**RBC Emerging Artist Award** – a \$5,000 cash prize presented to an emerging Toronto artist working in the new media or performing arts discipline in celebration of current accomplishments and future potential. Established in 2006 by RBC Foundation, this award is intended to support the development or completion of new work.

Roy Thomson Hall Award of Recognition – a \$10,000 cash prize presented to an individual, ensemble or organization to recognize creative, performing, administrative, volunteer or philanthropic contributions to Toronto's musical life. This award was established by the Volunteer Committee of Roy Thomson Hall in 1984 to recognize and thank the community that supported the conception, building and establishment of the new concert hall. In 2002, the Corporation of Massey Hall and Roy Thomson Hall (RTH) asked the TAF to manage the award.

William Kilbourn Award for the Celebration of Toronto's Cultural Life – a \$5,000 cash prize presented to an individual performer, teacher, administrator or creator in any arts discipline, including architecture and design, whose work is a celebration of life through the arts in Toronto. Established in 1996, this award is funded through an endowment made possible by private donors who wished to celebrate and remember the life of William Kilbourn who died in 1995. No person or organization may be selected for more than one TAF award within any one year

### **Appointment of Jurors**

A jury of up to 12 members will review candidate profiles and make a recipient recommendation for each award to Toronto Arts Foundation Board of Directors, which will make final determinations. Jury members must have recognized expertise, prestige, credibility and experience along with a sense of history and perspective. Each jury is comprised of participants who are practitioners of the arts, organizers, programmers, producers, curators, critics, commentators and lay specialists. TAF will endeavour to ensure that the majority of jury members are arts and culture professionals. Nominations through this process are received from the public.

Jury members are determined by extensive canvassing and consultation of arts and culture representatives, the general public and TAF board of directors and stakeholders.

The final list of jurors is made public in the form of a press release distributed to media, Council and Foundation stakeholders and arts service organizations. This information will be distributed in advance of commencement of the adjudication process.

### Remuneration

Individuals receive no remuneration for sitting on an awards jury except for one complementary ticket to the official awards presentation event.

### **Conflict of Interest**

It is assumed that all persons chosen as jurors are of unimpeachable integrity, and strive to uphold this standard. Therefore, if in the course of a jury's deliberations, any juror becomes faced with a conflict of interest, that person is expected to declare such conflict and withdraw from the selection/voting process.

A conflict of interest refers to a situation in which private interests or personal considerations may affect a jury member's judgment in acting in the best interest of the awards adjudication process.

Specifically, a conflict of interest exists where a jury member: has a financial interest in the success or failure of a candidate; has a personal interest in a specific candidate other than what is normally expected of an interested member of the arts community; or has any other reason which makes him/her unable to evaluate the candidate objectively.

### **Nomination and Selection Process**

Members of the arts community and general public are invited to submit names of individuals to be considered by the jury. Names must be submitted in writing with a biography and nomination rationale. Where appropriate, nominations may be illustrated by accompanying support material in the form of visual or text-based attachments. Jury members are precluded from participating in the nominating process.

In order to expedite adjudication, TAF staff will pre-evaluate award nominations and endeavour to produce a vetted long-list of candidates for jury review and deliberations. From that list, the jury will select a shortlist and recipient for each award. This shortlist will be made public in advance of the official awards presentation with the recipient announced the day of the event.

In addition to specific requirements for each award, deliberations will be guided by the following general assessment criteria: artistic strength and achievement of the candidate; strength of the candidate's artistic goals and objectives; contribution of the candidate to the development of arts and culture in Toronto; and the candidate's overall public impact including community engagement and animation.

The jury endeavors to reach unanimous decisions in its selection process. In the event that unanimity is not achieved, a decision may be reached by majority vote.

All jury deliberations are strictly confidential and final results of the adjudication process are confidential until made public at the official awards presentation event.

All facets of the jury process are managed by TAF staff.

The TAF reserves the right to amend these Policies and Procedures, without notice to any party.
